Each youth at the program is assigned to a care team that supports them as they navigate different situations during their stay at PASO. PASO uses trauma-informed Sanctuary Model tools to manage behaviors and natural consequences while supporting the youth. The program provides Motivational Interviewing Training, Collaborative Problem-Solving Training, NCI Verbal De-escalation Training, Whole Brain Child Training, and SB 710 Training.</p>

<p>A description of the steps the program has taken to decrease the use of restraint and involuntary seclusion.</p>	<p>The use of physical restraints and seclusion are prohibited in Morrison foster care programs. Initial and annual NCI training will continue for staff and resource parents. However, the physical restraint portion of the training will not be included. Morrison TFC/BH-TFC/PCRC programs are also currently implementing the Attachment, Regulation, and Competency (ARC) model to decrease the use of restraint. All Morrison foster care programs are implementing the Sanctuary Model, a trauma-informed framework. Programs have reminded resource families to utilize the Morrison On-call Support phone line.</p>
