Initial and annual NCI training continues for staff and resource parents. However, the physical restraint portion of the training will not be included. PCRC will continue to implement the Attachment, Regulation, and Competency (ARC) model to decrease the use of restraint. PCRC Programs does not use seclusion. PCRC Staff remind resource families/respice providers to utilize Morrison On-call support phone line if/when de-escalation support is needed.</p> <p>Morrison TFC/BH-TFC programs closed as of 06/30/23.</p>
