Morrison Child and Family Services (“**Morrison**”, “**we**”, “**us**”, or “**our**”) is a nationally recognized leader in behavioral health care, dedicated to providing high-quality, trauma-informed programs and services to children and families. We respect your privacy and value your trust. Morrison uses the personal data we collect to further our mission, which is helping kids be kids and supporting families when they need us most. The personal data we collect will depend on the nature of our interactions with you and the specific services we provide.

It is the policy of Morrison to respect the privacy of its donors and others with whom we interact. This privacy policy applies only to personal data collected through our websites, which includes <https://www.morrisonkids.org> and any other domain owned or operated by Morrison (the “**Sites**”).

Please read this privacy policy carefully. It was last updated on the date indicated above. We will post any changes to it here so you will know what personal data we gather on the Sites, how we might use that personal data, and whether we will disclose that personal data to anyone so that you are informed of your rights and can make choices in utilizing the Sites. Morrison reserves the right to change this privacy policy and the collection and use of personal data at any time.

**By accessing and using the Sites, you consent to the most recent personal data practices described in this privacy policy. Accordingly, if you do not agree to the terms of this privacy policy, do not use the Sites.**

## Jurisdiction-Specific Rights: Oregon, EEA & U.K.

If you are a resident of Oregon, this entire privacy policy applies to you. However, please see our [Oregon Privacy Addendum](#), which will inform you about your specific rights under Oregon law.

If you are located in the European Economic Area (“**EEA**”) or the United Kingdom (“**U.K.**”), this entire privacy policy applies to you. However, please see our [EEA and U.K. Privacy Addendum](#), which provides more information about which specific rights you have regarding the processing of your personal data under European law.

## Children Under the Age of 16

Although Morrison provides programs and services to children and families, and our Sites provide information about those services, , no one under age sixteen (16) may provide any information to or on the Sites, without first providing us with parental consent or authorization. We do not knowingly collect personal data from children under the age of sixteen (16). If you are under sixteen (16) years old, do not use or provide any information on the Sites or on or through any of their features, unless you first provide us with verified parental consent or authorization. If we learn we have collected or received personal data from a child under sixteen (16) years of age, without verification of parental consent, we will delete that personal data. If you believe we might have any personal data from or about a child under sixteen (16) years old, please contact us.

## Personal Data We Collect and Process

“Personal data” is any data or unique identifier that is linked to, or is reasonably linkable to, you or one of your devices as a consumer. It does not include deidentified data or data that is lawfully available through federal, state, or local government records, widely distributed media, or information reasonably understood to have been made lawfully available to the public by you.

We collect the following personal data on our Sites, which you provide directly to us. For example, we collect personal data when you make a donation on the Sites, create an account to access certain features of the Sites, send us an email, fill out a form, respond to a survey, register for an event, or otherwise communicate with us. The personal data that we may collect includes, but is not limited to:

- Personal Details: This includes your name, demographic information, contact details (such as address, email, and phone number), marital status, birth date, country, and official identification numbers.
- Financial Information: We may collect personal data related to donations made through the Sites.
- Communication Records: We may maintain personal data about your interactions with the Sites, including time and subject of your inquiries, as well as your preferred communication methods, and information you provide in online forms or surveys.

If you voluntarily provide us with your personal data, such as when you make a contribution, provide feedback, complete a survey, interact with us on social media, or send us an email, we may gather personal data through that communication. On certain pages on our Sites, such as our donation page, event registration forms, or an information request form, you may be asked to provide personal data such as demographics, credit card, and other information. We do not gather this personal data on our Sites or our affiliated giving websites without your permission. We may request your permission when you make donations or in other forms that you complete, online or otherwise.

## Processing of Donations

We accept donations from you only and do not directly collect or store payment information. We use third-party, PCI-compliant, payment processors, which collect payment information on our behalf in order to complete transactions with our donors. While our administrators are able to view and track actual donations via the client portals of the payment processors, we do not have access to, or process, credit card information. Please see the respective privacy notices of our listed payment processors for more information on their data collection and processing activities.

## Social Media

We use social media plug-ins (e.g., Facebook, LinkedIn, YouTube, X (formerly Twitter), and Instagram). These features may collect your IP address and/or other personal data as set forth in each social platform's privacy policy, which page you are visiting on our Sites, and may set a cookie to enable the feature to function properly. We also have a presence on some social media platforms, including Facebook, LinkedIn, YouTube, X (formerly Twitter), and Instagram. We may in some instances collect personal data when you interact with Morrison accounts or otherwise communicate with us through those accounts. Any personal data that you post on social media is governed by each social platform's privacy policy, and any personal data that we collect via our social media accounts will be processed in accordance with this privacy policy.

## Online Activity

When you visit the Sites, we collect information about your online activity. Information may be collected in a variety of ways, including indirectly.

When you access or use the Sites, we may automatically collect certain personal data about you, including:

- **Log Data.** As is true of most websites, we gather certain personal data automatically and store it in log files. This information may include IP addresses, browser type, device identifier, ISP, referring/exit pages, operating system, date/time stamp, clickstream data, platform type, and number of clicks in order to analyze trends, administer the Sites, collect broad demographics, information and other usage data for aggregate use. We may combine this automatically-collected log information with other personal data. We use log data to monitor use of our Sites, for security purposes and for technical administration. Morrison utilizes a variety of third-party vendors to assist in collecting and analyzing such data.
- **Device Information.** We may collect personal data about the device you use to access our Sites, including the hardware model, operating system and version, unique device identifiers, and mobile network information.
- **Information Collected by Cookies and Other Tracking Technologies.** We and our service providers may use various technologies to collect personal data, including cookies and web beacons. Cookies are small data files stored on your hard drive or in device memory that help us to, among other things, improve our Sites and your experience, see which areas and features of our Sites are popular and count visits. Web beacons are clear, electronic images that may be used on our Sites or in our emails and help deliver cookies, count visits, conduct cross-contextual behavioral advertising, understand usage and campaign effectiveness and determine if an email has been opened and acted upon. Some of these technologies may collect personal data about your online activities over time and across different websites. If you wish to not have this information used for the purpose of serving you targeted ads, you may opt-out through our cookie banner. You can also delete cookie files from your hard drive, or avoid them altogether, by configuring your browser to reject them or to notify you when a cookie is being placed on your device. ## Information Received From Third Parties

In furtherance of Morrison's philanthropic mission, we collect your personal data online from third parties where authorized by data protection laws, as well as collect information about you from other companies and organizations. When gathering your personal data, we may obtain it from various external sources, in accordance with applicable data protection laws:

- **Social Media Platforms:** Your public interactions with Morrison on social media and the personal data you disclose may be collected and used.
- **Third-Party Marketing Partners:** These entities may provide us with certain personal data about your philanthropic interests and giving capacity.

- Independent Organizations: Various other organizations, including other charitable organizations, may serve as sources of personal data.

This personal data collection enhances our ability to provide you with tailored services and make informed decisions. We prioritize data accuracy and transparency, with the objective that all personal data gathered is relevant, up-to-date, and obtained through lawful means.

## Sensitive Data

“Sensitive data” represents a specialized category of personal data requiring elevated protection and careful handling. We only collect the following categories of sensitive data when you provide it to us with consent for the purposes described in this policy. We do not sell or use your sensitive data for targeted advertising purposes, and only use your sensitive data as permitted by law. Morrison may track the following sensitive data if provided.

- Children’s information, which includes name and DOB, race and ethnicity, and health and medical information.
- Other information that may be required by law

We may collect sensitive personal data exclusively:

- For legitimate organizational purposes and to provide Services
- With explicit individual, parental, or legal guardian consent
- In compliance with regulatory requirements
- In execution of our programs and in furtherance of our mission

Our approach prioritizes:

- Minimal data collection (in accordance with this privacy policy)
- Purpose-specific utilization
- Confidentiality
- Regulatory compliance

## Photography and Video

Photos or video taken at our events, programs, or other interactions you have with us may be used electronically in online publications, our Sites, emails, social networking websites, such as Facebook, Instagram, YouTube, LinkedIn, or X (formerly, Twitter), or in other electronic or print forms of media. These images and videos may be retained in perpetuity as historical and archival records of Morrison. We will use such images and videos in accordance with this Policy. ## How We Use Your Personal Data

We may use personal data we collect or that you provide to us for the following:

- Donor Services: To provide and improve services related to donor recognition, events, and other donor support functions; to manage donations, track donor history, and administer charitable funds; and/or to maintain relationships with donors, organize Morrison events, facilitate giving programs, and foster ongoing engagement with the philanthropic community.
- Financial Management: To process donations, manage charitable funds, and handle any financial transactions with Morrison. We do not retain consumers' credit card, bank, or investment account information.
- Communication and Outreach: To send important updates and notices, respond to inquiries, organize events, and maintain ongoing connection with donors, staff, supporters, and community partners. To provide information about Morrison programs and events to prospective donors and the wider community.
- Research and Program Improvement: To conduct internal analysis for the improvement of Morrison programs, operations, and services.
- Legal Compliance: To fulfill legal obligations and comply with applicable laws and regulations (e.g., to assist with necessary documentation and compliance with charitable giving regulations).
- Security and Data Protection: To maintain our data security and donor privacy, including necessary notifications.
- Additional Services and Benefits: To provide other services to donors, prospective donors, and other persons.
- Mission Driven: To further our mission, which is helping kids be kids and supporting families when they need us most.

Any email address you provide may be used to send you information, respond to inquiries, and/or other requests or questions. We may also use your personal data to contact you about additional donor services that may be of interest to you. If you do not want us to use your personal data in this way, please contact us at [info@morrisonkids.org](mailto:info@morrisonkids.org)

We are committed to using your personal data responsibly and in accordance with applicable data protection laws and regulations.

## Sharing Your Personal Data

We share your personal data internally at Morrison to facilitate and manage the purposes listed above.

We may share user personal data with third parties for purposes related to the pursuit of our philanthropic mission. These are the following categories of third parties with whom we share your personal data:

- We may share your personal data to third-party representatives with whom we contract with to update our files, process and manage your financial payments and donations, and to Morrison-affiliated organizations in support of our goals and objectives. Our service providers also include third-party service providers that provide IT and web hosting, data analysis, information technology and related infrastructure provisions, solicitation or acknowledgment of charitable gifts, aggregate analysis and marketing activities as well as professional advisors such as auditors and attorneys.
- We may also publicize your name and your category of support in our honor roll of donors, annual reports and/or other donor recognition publications, which are publicly available, unless you specifically ask to remain anonymous (email [info@morrisonkids.org](mailto:info@morrisonkids.org) regarding donations).
- We may also share your personal data with government and law enforcement agencies, regulators, or other relevant authorities, to comply with legal processes applicable to us, enforce our terms of use or other policies, or to pursue available legal remedies or defend against legal claims. We may also share your personal data with lawyers and all interested parties, but exclusively in the case of the management of possible disputes and other legal matters where appropriate.
- We may also share your personal data with other third parties as you may so request, and as permitted by Morrison policies and applicable law.

## Data Retention

Morrison will retain your personal data only for as long as is necessary to fulfill the purposes for which it was collected, including to meet any legal, accounting, or reporting requirements. Once the retention period has expired, we will securely delete or anonymize your data. In determining the appropriate retention periods, we have considered the nature and sensitivity of the data, the potential risks of harm from unauthorized uses or disclosures, the purposes for which we process it, and applicable legal obligations.

Additionally, we cannot delete personal data when it is needed for the establishment, exercise or defense of legal claims (also known as a “litigation hold”). In this case, the personal data must be retained as long as needed for exercising respective potential legal claims.

## Data Protection and Security

We maintain reasonable technical and organizational measures designed to protect personal data from loss, misuse, alteration, or unintentional destruction. We have implemented various security measures designed to protect both the personal data and the general information that we receive

from you through the Sites. Whenever you give out personal data online, there is a risk that third parties may intercept and use that information. Although we seek to protect your personal data and privacy, we cannot guarantee the security of any personal data you disclose online. To the extent permitted under applicable law, we assume no liability or responsibility for disclosure of your personal data due to errors in transmission, unauthorized access by third parties, or other causes beyond our control.

Additionally, we carefully review payment systems used to ensure they meet our security expectations and are legally compliant.

Notwithstanding, no Internet or email transmission is ever fully secure or error free. In particular, email sent to or from the Sites may not be secure. Therefore, take special care in deciding what personal data you send to us via email. ## International Transfers

We are located in the United States, and the personal data that we collect is stored on servers located in the United States. This means that your personal data will be collected, processed, and stored in the United States, which may have data protection laws that are different from (and sometimes less protective than) the laws of your country or region, such as the General Data Protection Regulation 2016/679 (“**GDPR**”) in the European Union.

**By sending us personal data, you agree and consent to the processing of your personal data in the United States, which may not offer an equivalent level of protection to that required in other countries (particularly the EEA).**

We have implemented safeguards designed to ensure that the personal data we process remains protected in accordance with this privacy policy, including when processed internationally or by our third-party service providers and partners. The safeguards we may take at our discretion include, for instance, entering into specific agreements in connection with any onward transfers of personal data. We may implement other mechanisms and take similar appropriate safeguards with our third-party service providers and partners.

## Oregon Privacy Addendum

Specifically, the Oregon Privacy Addendum provides residents of Oregon additional information about their privacy rights under the Oregon Consumer Privacy Act (“**OCPA**”). This Oregon Privacy Addendum is intended only for residents of Oregon.

### Your Consumer Rights

#### *Know What Personal Data We Have*

You have the right to know whether we are processing your personal data, what personal data is being collected about you, whether it is disclosed, and to whom (as provided in the Policy).

#### *Access and Data Portability of Your Personal Data*

You can request access to your personal data. This enables you to receive a copy of the personal data we hold about you. We may request specific information from you to enable us to verify your identity. Your right to access your personal data is not absolute. If we cannot provide you with access to your personal data, we will inform you of the reasons, subject to any legal restrictions.

### *Correct Your Personal Data*

Morrison aims to ensure the personal data we possess is accurate. If you believe personal data about you is incorrect, incomplete, or outdated, you may request the correction or an update of that information. We will use reasonable efforts to revise it.

### *Delete Your Personal Data*

You may ask us to delete or remove personal data where there is no legal reason for us to continue using it.

### *Your Opt-Out Right*

Under OCPA, the “sale” of personal data includes both traditional sales for monetary consideration and disclosures of personal data for other valuable consideration. We do not engage in any “sales” of personal data as defined by the OCPA. You do have the right to opt-out of these “sales” of your personal data, as well as any processing of your personal data in connection with targeted advertising. ### *Withdraw Consent*

You have the right to withdraw any consent you have previously given us at any time. If you withdraw your consent, this will not affect the lawfulness of our collecting and processing of your personal data up to the point in time that you withdraw your consent. Even if you withdraw your consent, we may still use your information, provided it has been fully deidentified and does not personally identify you.

### *Exercising Your Privacy Rights*

To use an authorized agent to make a request on your behalf, we may need the authorized agent to provide proof that you gave the authorized agent signed permission to submit the request on your behalf. We may also require you to verify your identity directly with us.

We will respond to your written request without undue delay. We may require additional information to authenticate your request. If we are not able to honor any part of your request, we will notify you and, in our response, we will you with an explanation as to why we cannot do so.

### *Appeal Our Decision*

If we deny your request to exercise your privacy rights as described above, you may appeal our decision by writing to us at the address from which our response was sent within 45 days of the date of our response. Please provide any additional, relevant information you believe we should consider in evaluating your appeal.

If you are an Oregon resident, and, after you appeal our decision, we again refuse your request, you may have the right to file a complaint with the Consumer Justice Division of the Oregon Department of Justice.

## EEA and U.K. Privacy Addendum

Morrison has updated its policies regarding the recording and use of personal data for individuals residing in the U.K. and the European Union, in compliance with the General Data Protection Regulation 2016/679 (“**GDPR**”).

As explained in our privacy policy (the “**Policy**”), which informs you about the categories of personal data we collect when you visit <https://www.morrisonkids.org/>, or any other online platforms owned and operated by Morrison, as detailed in our Policy (the “**Sites**”); our practices for collecting, using, retaining, and protecting your personal data; and your rights to ensure proper management of this information.

For our users located in the EEA and the U.K., we must have a valid legal basis in order to process your personal data. Generally speaking, the main legal bases under the GDPR that justify our collection and use of your personal data are:

- *Performance of a contract* – When your personal data is necessary to enter into or perform our contract with you.
- *Consent* – When you have consented to our use of your personal data via a consent form (online or offline).

- *Legal obligation* – When we need to use your personal data to comply with our legal obligations.
- *Legal claims* – When your personal data is necessary for us to defend, prosecute or make a claim.
- *Legitimate interests* – When we use your personal data to achieve a legitimate interest and our reasons for using it outweigh any prejudice to your data protection rights.

## Staying In Control of Your Personal Data: Your Rights

If you are in the EEA or the U.K., you have certain rights in relation to your personal data:

- **The right to be informed** – our obligation to inform you that we process your personal data;
- **The right of access** – your right to request a copy of the personal data we hold about you (also known as a ‘data subject access request’);

- **The right to rectification** – your right to request that we correct personal data about you if it is incomplete or inaccurate;
- **The right to erasure** (also known as the ‘right to be forgotten’) – *under certain circumstances*, you may ask us to delete the personal data we have about you (unless it remains necessary for us to continue processing your personal data for a legitimate business need or to comply with a legal obligation as permitted under the GDPR, in which case we will inform you);
- **The right to restrict processing** – your right, *under certain circumstances*, to ask us to suspend our processing of your personal data;
- **The right to data portability** – your right to ask us for a copy of your personal data in a common format (for example, a .csv file);
- **The right to object** – your right to object to us processing your personal data (for example, if you object to us processing your data for direct marketing);
- **Rights in relation to automated decision-making and profiling** – our obligation to be transparent about any profiling we do, or any automated decision-making; and
